  - b. DTI Business name Registration or SEC Registration Certificate

  - d. BIR Registration Certification, which contains the Taxpayer’s Identification Number
  - e. Statement of prospective bidder that is not “blacklisted” or barred from bidding of the Gov’t.
  - f. Certificate of No-Relation to Procuring Entity
  - g. Valid joint venture agreement (if applicable)
  - h. Letter authorizing BAC to verify any or all of the documents submitted for eligibility check
  - i. Audited financial statements, stamped “received” by the BIR or its duly accredited and authorized institutions, for the immediately preceding calendar year, showing among others, the prospective bidder’s total and current assets and liabilities.
  - j. Certification under oath that each of the documents submitted in satisfaction of the eligibility requirements is an authentic and original copy, or true and faithful reproduction of the original, complete and that all statements and information provided therein are true and correct.
  - k. Duly signed Statement attesting to have complied with the responsibilities listed in GPRA IRR-A Section 17.7.1
  - l. Statement of on-going and similar completed government and private contracts, including contracts awarded but not yet started.
3. Bid forms are available from January 11-17, 2011 at the office of the MPDC, Jagna, Bohol and only upon payment of non-refundable amount equivalent to the reproduction cost of the said documents.
