## MDRRMC RESOLUTION NO. 01-2011

**A RESOLUTION REQUESTING THE ADOPTION OF MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT PLAN (Annex A) AND APPROVAL OF THE UTILIZATION OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (Annex B) OF THE MUNICIPALITY JAGNA CALENDAR YEAR 2011 FOR USE TO SUPPORT DISASTER RISK REDUCTION ACTIVITIES SUCH AS, BUT NOT LIMITED TO, PRE-DISASTER PREPAREDNESS PROGRAMS AND STAND-BY FUND (QUICK RESPONSE FUND) IN TIMES OF STATE OF CALAMITY FOR RELIEF AND RECOVERY PROGRAM IN THE MUNICIPALITY OF JAGNA, JAGNA, BOHOL.**

WHEREAS, Republic Act 10121 IRR Rule 6 Section 4 (7) the Municipal Disaster Risk Reduction Management Council in coordination with its Action Officer, is mandated to formulated and implement a comprehensive and integrated LDRRM Plan in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in closed coordination with the municipal development council;

WHEREAS, on February 7-8, 2011 the MDRRMC and the 33 Punong Barangays conducted a 2-Day Orientation and Planning Workshop to identify, assess and manage the hazards, vulnerabilities and risks that may occur in our locality;

WHEREAS, the MDRRM Plan and budget and the proposed programming of the MDRRM Fund was presented to the Municipal Development Council during its meeting on February 23, 2011 for coordination and consultation;

WHEREAS, Rule 18 Section 1 of the IRR of RA 10121 specifies that utilization of the Local DRRM Fund shall set aside to support disaster risk reduction activities such as, but not limited to, pre-disaster preparedness programs that is based on the MDRRMC Plan;

NOW WHEREFORE, on motion of **Mr. Camilo A. Rizano** and duly seconded by **Mr. Antioco C. Lloren** and Engr. **Josefina S. Rañoa** Be it,

RESOLVED, that the MDRRMC Plan be adopted and the amount of Two Million Six Hundred Eighty Two Thousand Three Hundred Fifty Pesos (Php 2, 682, 350.00) from 5% Calamity Fund Appropriation 2011 be utilized to support disaster risk reduction activities such as, but not limited to pre-disaster preparedness program based on the MDRRMC Plan of the municipality.

RESOLVED FURTHER, that copies of this resolution be furnished the 7<sup>th</sup> Sangguniang Bayan of Jagna, Jagna, Bohol for its review and approval.
