A RESOLUTION APPROVING THE SUPPLIES OF GROCERY ITEMS TO THE VICTIMS OF FLASH FLOODS OCCURRENCE ON MARCH 16, 2011, AUGUST 30, 2011 AT BRGY PAGINA AND SEPTEMBER 1, 2011 OF BRGY CAN-UPAO RESPECTIVELY BE GIVEN TO THE AFFECTED FAMILIES THE AMOUNT RECOMMENDED BY THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICER IN ACCORDNACE TO THE DAMAGE ASSESSMENT REPORT.

WHEREAS, Republic Act 10121 IRR Rule 6 Section 4 (17) The Municipal Disaster Risk Reduction Management Council in coordination with its Action Officer, is mandated to respond to and manage the adverse effects of emergencies and carry out recovery activities in the affected area;

WHEREAS, the approved MDRRM Plan and Budget of 2011 has an appropriation allotted aid to disaster victims;

WHEREAS, MDRRM Fund also appropriated an amount for the Quick Response Fund (30% of total calamity fund) as a stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disaster may be normalized as quickly as possible.
