Executive Order No. 17, s. 2013

AN ORDER RECONSTITUTING THE COMPOSITION OF THE JAGNA WATERWORKS SYSTEM BOARD AND ITS FUNCTIONS

WHEREAS, the Local Government Code of 1991 mandates the decentralization and devolution of authority to LGUs in providing for certain basic services, which include safe potable water;

WHEREAS, at the local level, the LGUs are responsible for providing reliable water supply to their constituents, whether these are in the form of levels I, II or III systems, depending on the expressed demand by the community for these services;

WHEREAS, LGUs shall maintain overall responsibility for ensuring consumer satisfaction through the exercise of institutional powers in collaboration with other national regulatory agencies, and other sectors of the community.

NOW THEREFORE, I, **FORTUNATO R. ABRENILLA**, Municipal Mayor of Jagna, Bohol by virtue of the powers vested in me by law do hereby order the constitution of the Municipal Waterworks Management Council.

Section 1. Composition. The Municipal Waterworks Management Council shall be composed of the following:

Section 2. Functions Jagna Waterworks System Management Board. The Waterworks Council shall have the following duties and functions:

1. Formulate strategies through a short, medium and long term plan to ensure sustainability of potable water supply, greater access of potable water by the constituents and enhanced twenty-four (24) hour service delivery through:
 - a. Identification of additional water source/s
 - b. Use of mechanisms/technologies for water treatment
 - c. Use of technologies for water transmission
2. Ensure financial viability of water supply system wherein its revenues can cover for all costs related to capital and operation and maintenance, including providing for reasonable reserves for future expansion.
3. Ensure cost-effective and reliable services to consumers.
4. Review and approves Jagna Waterworks System contract of services between JWS and the Consumers.
5. Formulate policies related to Jagna Waterworks System operation and project developments.

Section 3. Effectivity. This Executive Order shall take effect immediately.
