WHEREAS, Tropical Depression "Queenie" hit our municipality on November 26, 2014 which devastated our most vital social, economic and institutional infrastructure;

WHEREAS, all of the 14 coastal barangays of the municipality are severely affected with varying degrees of damage to property;

WHEREAS, all 14 coastal barangays have declared a state of calamity in each of their territorial jurisdiction;

WHEREAS, Tropical Depression Queenie has destroyed the means of livelihood of the fisherfolks of these 14 coastal barangays;

WHEREAS, Tropical Depression Queenie has destroyed the crops, poultry and livestock and other agricultural products of other barangays within the municipality;

WHEREAS, disruption of electrical system and potable water system is experienced;

WHEREFORE;

BE IT RESOLVED by the 8th Sangguniang Bayan of Jagna, Bohol in session duly assembled:

"TO DECLARE THE MUNICIPALITY OF JAGNA, BOHOL IN A STATE OF CALAMITY."





