#### **MUNICIPAL ORDINANCE NO. 5-06-2010**

## AN ORDINANCE APPROVING THE COMPREHENSIVE MUNICIPAL DEVELOPMENT PLAN (MDP) OF JAGNA 2010-2016 JAGNA, BOHOL

(Sponsored by Coun. Senen C. Lloren)

WHEREAS, the Local Government Code of 1991 or RA 7160 has mandated that all Local Government Units (LGUs) formulate their own development perspectives and priorities in their respective localities;

WHEREAS, the Municipality of Jagna has formulated its Comprehensive Municipal Development Plan which will provide for the directions of sustained development for the next six (6) years;

WHEREAS, the Comprehensive Municipal Development Plan of Jagna is reflective of the situation of the municipality and aspirations for the people as the plan is a joint undertaking of multi-stakeholders that has evolved through participatory activities beginning at the barangay level to municipal level consultations and workshops;

#### WHEREFORE;

BE IT ORDAINED by the 6<sup>th</sup> Sangguniang Bayan of Jagna, Bohol in session duly assembled, that:

**SECTION 1**. **TITLE.** This Ordinance shall be known as the approved **Comprehensive Municipal Development Plan of Jagna, Bohol.** 

**SECTION 2. SCOPE OF THE ORDINANCE.** This Ordinance shall cover all the activities involving the implementation of the Comprehensive Municipal Development Plan within the next ten (10) years from the date of the approval of this ordinance.

**SECTION 3. PURPOSE.** This Ordinance is enacted to ensure that the municipal development framework, direction and perspective shall be based on the Comprehensive Municipal Development Plan for sustainability and attainment of the Vision and Mission in the next years.

**SECTION 4. DECLARATION OF POLICY**. It is hereby declared the policy of the Municipality of Jagna to institutionalize the Comprehensive Municipal Development Plan and adopt and implement the same as it provides the direction of the development path of the municipality in the next ten years.

**SECTION 7. REPEALING CLAUSE.** All Ordinances, rules and regulations, Executive Orders or parts thereof, which are inconsistent with this Ordinance, are hereby repealed or modified accordingly.

**SECTION 8. EFFECTIVITY.** This ordinance shall take effect upon approval.
