MUNICIPAL ORDINANCE NO. 8-09-2010

AN ORDINANCE REPEALING SECTION 13(4), ARTICLE "G" OF MUNICIPAL ORDINANCE NO. 8-09-2007 OR THE JAGNA SENIOR CITIZENS ORDINANCE OF 2007.

(Sponsored by the Committee on Social Services & Gender Concerns)

WHEREAS, Section 13(4), Article G of Municipal Ordinance No. 8-09-2007 provides for the creation of the Committee on Senior Citizens in the Sanggunian as part of their Internal Rules with the responsibility being assigned is only on matter related to the elderly in so far as "in aid of legislation" is concerned;

WHEREAS, the new Internal Rules of the 7th Sanggunian already provides the different committees to function on matters falling under its concerns but none is created as a separate Committee on Senior Citizens as its lone responsibility or concern is already taken and included under the tasks of the Committee on Social Services and Gender concerns as agreed unanimously;

WHEREFORE;

Be it ordained by the 7th Sangguniang Bayan of Jagna, Bohol, in session duly assembled that:

SECTION 1 – Section 13(4) Article "G" of Municipal Ordinance No. 8-09-2007 otherwise known as the Senior Citizens Ordinance of 2007 as aforestated is hereby repealed and declared of no force and effect.

SECTION 2. Matters concerning the elderly and/or senior citizens as far as legislative measures are concerned shall now be under the Committee on Social Services and Gender Concerns as provided for in the Internal Rules of Procedure of the 7th Sangguniang Bayan.

SECTION 3. Other provisions in Municipal Ordinance No. 8-09-2007 not affected herewith shall continue to be enforced and has effect.

SECTION 4. This Ordinance shall take effect upon its approval.
