Prospective bidders should have experience in undertaking a similar project within the last 3 years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Only Bids from Bidders who pass the eligibility check will be opened.

The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification state in order to finally determine his responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedures.

Interested REGISTERED BIDDERS may obtain further information from Municipality of Jagna, Bohol through its Bids and Awards Committee (BAC) and inspect the bidding documents of registered bidders/suppliers at the address given from 8:00 AM – 5:00 PM.

A complete set of Bidding Documents may be purchased by interested registered bidders from same address and upon payment of a non-refundable fee in the amount of ( P 1,000.00) to the Municipal Treasurer. The method of payment will be in Cash. The prospective Bidder or his authorized representative shall receive the Bidding Documents personally.
