#### Executive Order No. 32, s. 2013

## AN ORDER CONSTITUTING THE COMPOSITION OF MUNICIPAL ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS) COUNCIL AND DEFINING ITS **DUTIES AND FUNCTIONS**

WHEREAS, Article II, Section 10 of the 1987 Constitution states that the State values the dignity of every human person and guarantees full respect for human rights while Section 15 of the same documents states that the State shall promote the right to health of the people and instill health consciousness among them;

WHEREAS, Article 3 of the United nations Convention of the Elimination of All forms of Discrimination Against Women (CEDAW) provides that it is the obligation of the state to take all appropriate measures to ensure the full development and advance for women, for the purpose of guaranteeing them the exercise and enjoyment of human rights and fundamental freedom on the casis of equality with men;

WHEREAS, Acquired Immune Deficiency Syndrome (AIDS) is a disease/condition that recognizes no territorial, social, political and economic boundaries thus, the need to take concerted action.

NOW THEREFORE, I FORTUNATO R. ABRENILLA, Municipal Mayor of Jagna, Bohol by virtue of the power vested in me by law do hereby order the constitution on the Municipal AIDS Council.

Section 2. Duties and Functions of the AID Council. The AIDS Council shall have the following duties and functions:

- 1. Formulate policies and strategies for the prevention and control of HIV/AIDS;
- 2. Prepare short and medium term plans for the prevention and control of HIV/AIDS;
- 3. Provide education and information dissemination activities on the prevention and control of STI/HIV/AIDS;
- 4. Identify and prepare remedies to problem in program implementation, program coordination, gaps in policy guidelines and enhance local multi-sectoral response to HIV/AIDS;
- 5. Recommend to the Sangguniang Bayan enactment of laws that shall control and prevent the spread of HIV/AIDS;
- 6. Monitor and evaluate the implementation of plans

Section 3. Effectivity. This Executive Order shall take effect immediately.
