CREATION OF THE LGU PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTING TEAM OF LGU-JAGNA, BOHOL.

WHEREAS, pursuant to the provision of the Local Government Code of 1991 (RA7160), the Local Government has jurisdiction over all programs and projects designated for the promotion and general welfare of its constituents;

WHEREAS, the Performance Challenge Fund (PCF) for Local Government Units is a flagship program of the DILG that serves as a facility that will help stimulate LGUs that put premium on transparency and accountability to enable them to avail themselves of financial support to jumpstart and sustain local socio-economic development initiatives supportive of national government goals and priorities. It is an incentive fund to eligible LGUs to support the implementation of high-impact capital investment projects in the Annual Investment Program (AIP);

WHEREAS, the Performance Challenge Fund (PCF) is being administered by the Department of the Interior and Local Government (DILG) in collaboration with the Department of Budget and Management (DBM) to recognize LGUs with exemplary performance in Admin, Social, Environment and Economic Governance and recognize good governance performance particularly in the adoption of good housekeeping along the governance areas of developmental planning, sound financial management, transparency and accountability and valuing performance monitoring;

NOW WHEREFORE, I, FORTUNATO R. ABRENILLA, Municipal Mayor of Jagna, Bohol, and by the authority vested in me by law do hereby order -

Article I. CREATION. There shall be created a PCF Project Implementing Team for the Municipality of Jagna, Bohol.

Article II. COMPOSITION. The PCF Project Implementing Team of Jagna, Bohol shall be composed of the following members:

Article III. OBJECTIVE. To enable and support Local Authorities to achieve sustainability in their services in rural and urban governance and assist in the attainment of the Millennium Development Goals. The local authorities will be facilitated to take informed and well-planned decisions .

Article IV. EFFECTIVITY. This Executive Order shall take effect immediately.
