**RESOLUTION NO. 2013-454**

**REITERATING AND CONFIRMING THE DECLARATION OF A STATE OF  
CALAMITY IN THE ENTIRE PROVINCE OF BOHOL.**

**(Motion En Masse)**

"WHEREAS, this August Body, in an emergency session called for by the Honorable Governor in the wake of a 7.2 magnitude earthquake that struck our province on October 15, 2013 and devastated our most vital social, economic, and cultural infrastructure, including the Provincial Capitol, declared a state of calamity throughout our territorial jurisdiction;

"WHEREAS, diligent efforts were exerted to immediately contact all the Members of this August Body, and five (5) responded with dispatch and trooped to the Governor's Official Residence and attended that emergency session while six (6) others expressed that they were in favor of such declaration but could not personally attend the session due to the impassable roads and bridges blocking their way;

"WHEREAS, today is our Regular Session and some roads and bridges were already cleared and paved the way for most of the Members of this August Body to attend this session;

"WHEREAS, as of this day, reports indicated that damages have already amounted to more than Half-A-Billion Pesos, at least 151 lives lost and counting, while hundreds of others wounded, thousands of families left homeless, and almost four hundred schools destroyed, even as our vigorous relief and rescue operations are underway;

"WHEREAS, our province and its people continues to be haunted by numerous aftershocks, strong enough to make them cower in fear and uncertainty;

"WHEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Panlalawigan of Bohol in session duly assembled –


To reiterate and confirm our earlier declaration of a state of calamity in the entire Province of Bohol.

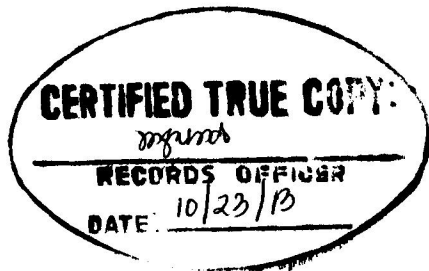
